Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler AG (DAG), the manufacturer of Mercedes-Benz vehicles, has decided that a defect, which relates to motor vehicle safety, exists in a small number of certain Model Year 2008 – 2017 E-Class, C-Class, GLC-Class, G-Class, CLA-Class, AMG GT, CLS-Class, S-Class, SL-Class, and ML/GL/GLE/GLS-Class vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

#### What is the CONCERN?

On the affected vehicles, various control units may have been updated with incorrect software, which among other things, could potentially affect the correct deployment of the airbags in the event of a crash. If the airbags do not deploy as intended in the event of a crash, there would be an increased risk of injury to occupants.

### What will your DEALER DO?

An authorized Mercedes-Benz dealer will update the affected Control Modules on the affected vehicles. <u>This service will be provided free of charge</u>. We are dedicated to always delivering the best customer experience, and respect for your time is a top priority. While the minimum repair time is approximately **30 minutes**, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time.

If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations.
