### Triple E Recreational Vehicles Recall CA#8593-1

This notice is sent to you in accordance with the requirements of the National Traffic & Motor Vehicle Safety Act. Triple E Recreational Vehicles has decided that certain 2017 Wonder W24MB Motorhomes manufactured between August 18/2016 & February 28/2017 fail to conform to Federal Motor Vehicle Safety Standard

#### Description of Noncompliance:

The alternative “EXIT” decal is missing from the driver side cab door. In the case of an evacuation of the motorhome, the occupant may not remember the driver side cab door is an exit.

#### To Have This Modification Performed:

We request your assistance to have this noncompliance issue corrected. The alternative “EXIT” decal is supplied in this mailing. Please affix the decal as specified in the enclosed photo, when completed sign the enclosed form and return by mail or e-mail.

**If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.**
