IMPORTANT SAFETY RECALL

Reprogram Powertrain Control Module

Dear [Name],

This notification is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA has decided that a defect, which relates to motor vehicle safety, exists in certain [2014 Model Year FIAT 500L] vehicles equipped with a 1.4L engine.

WHY DOES MY VEHICLE NEED REPAIRS?

Your vehicle ^[1] may experience a diminished ability to accelerate or to maintain vehicle speed due to a software calibration issue in the Powertrain Control Module (PCM). This incorrect PCM software calibration could limit the engine to only idle speed and torque even if the throttle is fully depressed; when the throttle is fully released and then depressed again, proper operation resumes.

This safety defect may result in the diminished ability to accelerate or to maintain vehicle speed when expected. **Diminished ability to accelerate or maintain vehicle speed may result in a vehicle crash. This condition may occur without warning.**

HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE

FCA will repair your vehicle ^[2] free of charge (parts and labor). To do this, your FIAT Studio will reprogram the PCM with new software. In addition, your FIAT Studio will require your vehicle for proper check-in, preparation, and check-out during your visit. Your time is important to us; please be aware that these steps may require more time. The estimated repair time is one hour. We recommend that you schedule a service appointment to minimize your inconvenience. Please bring this letter with you to your dealership.

WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?
