Dear Freightliner Sprinter Owner,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler AG ('DAG'), the manufacturer of Freightliner Sprinter, has determined that a defect, which relates to motor vehicle safety, exists in a small number of certain Model Year 2013 - 2014 Sprinter vehicles. Our records indicate that your vehicle is included in the affected population of vehicles. **A remedy is now available for your vehicle.**

What is the CONCERN?

On the affected vehicles, various control units may have been updated with incorrect software, which among other things, could potentially affect the correct deployment of the airbags in the event of a crash. If the airbags do not deploy as intended in the event of a crash, there would be an increased risk of injury to occupants.

What will your DEALER DO?

An authorized Freightliner Sprinter dealer will update the affected control units on the affected vehicles. **This service will be provided for free.** While the minimum repair time is approximately **30 minutes**, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Freightliner Sprinter dealer will also check for other repair measures which might be applicable to your vehicle which may increase the required working time. You will not be charged for other service or repairs unless so requested.

If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations.

Reimbursement to Customers for Repairs Performed Prior to Recall

If you have already paid to have this recall condition corrected you may be eligible to receive reimbursement. Requests for reimbursement may include parts, labor, fees and taxes. Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Freightliner dealer. The following documentation must be presented to your dealer for reimbursement.

Original or clear copy of all receipts, invoices and/or repair orders that show:

- The name and address of the person who paid for the repair.
- The Vehicle Identification Number (VIN) of the vehicle that was repaired.
- What problem occurred, what repair was done, when it was done and who repaired it.
- The total cost of the repair expense that is being claimed.
- Proof of payment of repair (copy of front and back of cancelled check, or copy of credit card receipt).
- Reimbursement will be made by check from your dealer. If your claim is denied you will receive a letter from MBUSA within 60 days of receipt with the reason(s) for the denial.
