This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2016 thru 2018 Model Year KZRV Venom Fifth Wheels. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to his recall were not manufactured with the proper propane tubing in the cook top burner box. If not replaced, the rubber propane line could melt and result in a leak. This could result in a fire. The remedy is to install the correct copper tubing in the cook top. This defect will be corrected at no expense to you, the owner. The repair should take approximately 30 minutes to complete.

What we need you to do

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.
