Triple E Recreational Vehicles Recall CA#8645-1

This notice is sent to you in accordance with the requirements of the National Traffic & Motor Vehicle Safety Act. Triple E Recreational Vehicles has decided that certain 2016 & 2017 Wonder W24MB motorhomes manufactured between December 2015 & March 2017 fail to conform to Federal Motor Vehicle Safety Standard

Description of Noncompliance:

The Ford Transit Chassis frame extension adapter does not have 4 (Four) M12 x 90mm grade 10.9 bolts installed for extra rigidity for the frame extension. This could cause the frame and/or frame extension structure to distort when towing, which could increase the risk of a crash causing injury and/or damage to property.

To Have This Modification Performed:

We request your assistance to have this Safety defect corrected. Dealers will perform the necessary repairs. Please contact your selling dealer as soon as possible to arrange for an appointment to have this Recall performed. The recall will be performed at no charge to you. The time needed to complete this repair is approximately 1 hour. If you choose to have this Recall performed by a service center other than your dealer prior authorization is required.

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
