This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2018 Model Year KZRV Recreational Vehicles. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to his recall were manufactured with Federal Compliance labels that do not contain the vehicle's date of manufacture. The repair should take approximately 5 minutes to complete.

What we need you to do

Please install the enclosed Federal Certification label over the existing label on your recreational vehicle per the enclosed instructions. If you have any concerns in performing this remedy, you should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.
