

July 2017 NHTSA Recall 17V-397

IMPORTANT SAFETY RECALL

This notice applies to your vehicle:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

WHAT IS THE REASON FOR THIS NOTICE?

Honda has decided that certain 2018 model year Odyssey vehicles fail to conform to the requirements of Federal Motor Vehicle Safety Standard, No. 208, Occupant crash protection. These vehicles may have third row center seat belt buckles that may not latch properly. In the event of a crash, an unlatched seatbelt may increase the risk of injury to the seat occupant.

WHAT WILL HONDA DO?

The dealer will inspect and replace the third row seat belt if necessary. This inspection and possible repair will be completed free of charge.

WHAT SHOULD YOU DO?

Please call any authorized Honda dealer and make an appointment to have your vehicle inspected and repaired if necessary, at no charge to you. Once you make an appointment for your vehicle, be advised that the total inspection and replacement process may take approximately 30 minutes. However, your dealer can provide you with a better estimate of the overall time for this service visit, as it may be necessary to make your vehicle available for a longer period of time. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information!

CHECK YOUR VEHICLE FOR OPEN RECALLS

You can check your vehicle's eligibility for repair under this or any other recall. Please visit the *Honda Recall Lookup* tool at www.recalls.honda.com and enter your Vehicle Identification Number (VIN).

OWNER INFORMATION

You received this notice because government regulations require that notification be sent to the last known owner of record. Our records are based primarily on state registration and title data, which indicate that you are the current owner of this vehicle. If this is not the case, or if any of the information is not correct, please complete, <u>sign</u> and return the Information Change Card and we will then update our records. If you are a lessor of this vehicle, federal regulations require you to forward this notice to your lessee within ten days.
