! IMPORTANT SAFETY RECALL!

MODIFICATION TO RIGHT HAND SWITCHCUBE CONNECTOR

This notice applies to your motorcycle:

Model: Street Cup

VIN: SMTD50GN000000000

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Triumph Motorcycles Ltd has decided that a defect which relates to motor vehicle safety exists in certain Street Cup motorcycles. Your motorcycle, with the VIN shown above, may be affected. Triumph is conducting a safety recall to address the condition.

The reason for this recall notice:

Your motorcycle is supplied with hazard warning light functionality. When engaged, both the left hand and right hand front and rear indicators will illuminate and flash in unison. The hazard light electrical wiring from the right hand handlebar switch cube is connected to your motorcycle's main harness via an electrical block connector located within the head lamp bowl. On some motorcycles there is insufficient free length in the wiring to accommodate the full steering movement. Where there is insufficient free length, the wires will be stretched and may become damaged. Once damaged, hazard warning light functionality is compromised and they may not operate. These circumstances will not affect your individual indicator operation. Your left hand and right hand indicators will continue to work normally. Loss of hazard warning light functionality presents an increased risk to your safety.

What Triumph Motorcycles Ltd & your dealer will do:

Triumph Motorcycles Ltd has authorized your dealer to fit a new electrical block connector and additional length of wiring that will provide acceptable free length. This repair will be performed free of charge to you, including parts and labour. This repair should take less than 45 minutes. However, it may be necessary to make your motorcycle available for a longer period of time.

What you must do to ensure your safety:

Please make an appointment with your authorized Triumph motorcycles dealer to have this important remedy performed on your motorcycle as soon as possible.

Federal regulations require that any vehicle lessor receiving this recall notice forward a copy of this notice to the lessee within 10 days.

If you need help:

Please contact your authorized Triumph dealer should you have any questions or encounter any difficulty regarding this recall. In the event your dealer is unable to remedy your motorcycle, please contact Triumph Motorcycles America on 1-678-854-2010.
