This notice applies to your vehicle, VIN:

Dear Hyundai Ioniq Electric owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Hyundai has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2017 Hyundai loniq Electric vehicles produced at Hyundai Motor Company beginning on November 17, 2016 through March 30, 2017. Our records indicate that you own or lease the vehicle identified by the VIN on this notice.

What is the problem?

The aluminum housing for the Electronic Power Control Unit (EPCU) used to supply power to the vehicle's motor and charge the vehicle's high-voltage battery system may contain voids, allowing coolant to contact the control unit's circuit board, potentially causing the vehicle to stall. A loss of motive power can increase the risk of a crash.

What will Hyundai do?

Your Hyundai dealer will inspect the vehicle's Electronic Power Control Unit and replace if necessary. This procedure will be performed at no charge to you. The actual time required to perform the inspection procedure will take approximately 1 hour, however your vehicle may be needed longer; therefore, we recommend scheduling a service appointment to minimize inconvenience.

What should you do?
