This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2017 and 2018 Model Year KZRV Travel Trailers. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall The vehicles subject to his recall were built with a standard 110V electrical outlet rather than a Ground Fault Circuit Interrupter (GFCI) outlet in the outside kitchen compartment. An electrical shock can result injury or death.

What we will do The remedy is to replace the standard outlet with a GFCI outlet. The repair should take approximately 60 minutes to complete.

What we need you to do You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.  If you had appropriate repairs completed prior to receipt of this recall notice, and if you incurred any direct cost in connection with obtaining such repair, you may be eligible to receive reimbursement from KZRV by contacting the **KZRV Warranty/Service Department**.
