Dear Supreme Truck Body Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Supreme Corporation has decided that certain model year 2017 Supreme Signature Van, Iner-City and Kold King truck bodies equipped with rear reflex reflectors fail to conform to Federal Motor Vehicle Safety Standard No. 108, *Lamps, reflective devices, and associated equipment*. Our records indicate that your vehicle(s) identified above may be affected. Supreme is conducting a safety recall to address this condition.

What is the Issue?

Certain Supreme truck bodies were not equipped with rear and/or side intermediate reflex reflectors resulting in a non-compliance of FMVSS 108. Lack of reflective devices on the vehicle results in decreased visibility, increasing chance of rear or side crash.

What Should You Do?

Please verify that reflex reflectors are mounted on the rear and side of the vehicle. If they are not, replacements have been provided with this letter. Install them according to the included diagram and notify the Supreme Warranty Department of which decals were installed at (844) 352-4921 or recall@supremecorp.com.

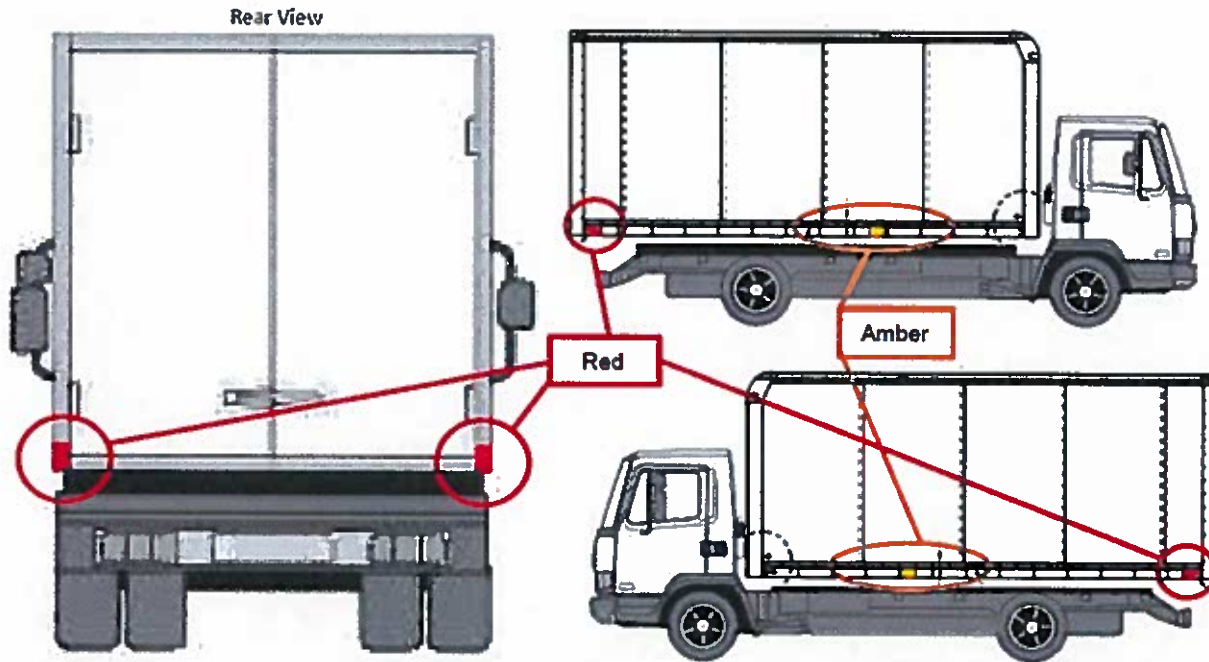

1. One on each side of vertical centerline, at same height, as far apart as practicable. Must be free of any obstructions such as closed liftgates or any other component installed on the rear frame. Reflectors must be completely visible when operator is driving the vehicle.
2. Amber reflectors must be installed on any truck that has a body length of 18 feet or greater, (per Supreme standards which covers all chassis configurations to be sure to always comply with FMVSS requirements)
