



IMPORTANT SAFETY RECALL

This notice applies to your 2018 Grand Design Reflection 297RSTS, VIN 573TR3

December 18, 2017

Dear Grand Design RV Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Grand Design RV has decided that a defect which relates to motor vehicle safety may exist with the tire clearance on the off-door side (street side) of your recreational vehicle.

! IMPORTANT !

- Your vehicle falls within the recall population.
- You should immediately schedule an appointment with your dealer to have your vehicle inspected and repaired.
- **Do not** operate your vehicle fully loaded or on rough surfaces until the recall repairs have been completed.

Why is a recall being conducted?

On select 2018 Reflection 297RSTS model vehicles manufactured between September 1, 2017 and November 7, 2017, the off-door side (street side) forward tire has insufficient clearance to the slide room ram in the retracted position. As a result, the tire may contact the slide ram while in transit under full load and/or heavy tire jounce. If this were to occur, the potential exists for tire damage and a possible blowout, potentially resulting in a loss of vehicle control and/or crash.

What are we doing about the problem?

On affected vehicles, dealers will install a lift kit at each of the axle hangers, which will provide adequate clearance between the tire and slide out ram. Stock quantities of the lift kit are readily available. Grand Design dealers have been notified of this recall and have the required repair instructions available. Repair is estimated to take no more than 5 hours. There will be no charge for this service.

What should you do?

Contact your selling or nearest Grand Design RV dealer as soon as possible to schedule an appointment. If your distance from a Grand Design dealer is significant, please contact us at 574-825-9679 so we can work with you to make other arrangements to have the needed repairs completed. You should not operate your vehicle fully loaded or on rough surfaces until the repairs have been completed.

What if I no longer own this recreational vehicle?

If you are the lessor of this vehicle, please forward a copy of this notice to the lessee within ten days to comply with federal regulations.
