## CONDITION SUMMARY:

#### SITUATION:

Following the recent Customer Letters sent as part of Safety Recall P082, this interim bulletin is released to support retailers where Customers may have serious concerns following receipt of the initial defect notification letters.

This Recall Action provides for the replacement of the passenger airbag until such time as Customers are notified of the availability of the remedy part. Customers may raise concerns or feel that they cannot continue to use their vehicle in an unrepaired state. Immediate advice to Customers, repeated here for ease of reference, is:

'Jaguar Land Rover North America is not aware of any case of airbag module rupture on our vehicles. Nonetheless, if you are uncomfortable while waiting for the repair, you may elect to avoid having a passenger sit in the front passenger seat until the recall repair has been performed.'

#### ACTION:

Where Customers are unwilling to adhere to the above advice, to support Customers and provide reassurance, in the first instance, make sure that the vehicle is included in Safety Recall P082. Once the VIN is confirmed as eligible, the process identified in the Workshop Procedure is to be followed.

Check DDW to ensure that a vehicle is affected by this program prior to undertaking any rework action.

At the time of confirming a booking for vehicle repair, ensure that **all** outstanding Recalls and Service Actions are identified to ensure the correct parts are available and adequate workshop time is allocated for repairs to be completed at one visit.

Warranty claims must be submitted quoting the Program Code together with the relevant Option Code. The SRO and parts information is included for information

only. The Option Code(s) that allows for the drive in / drive out allowance can only be claimed if the vehicle is brought back into the workshop for this action alone to be undertaken.

Repair procedures are under constant review and therefore times / prices are subject to change; those quoted here must be taken as guidance only. Refer to TOPIx to obtain the latest repair time.

Warranty claims must be submitted or payment within 30 calendar days of completion of the repair.


