IMPORTANT SAFETY RECALL INTERIM NOTICE

THIS NOTICE APPLIES TO YOUR VEHICLE RECALL 170110REV NHTSA RECALL CAMPAIGN 17V034 March 2017

Dear Valued Customer,

This notice is sent to you in accordance with the requirements and approval of the National Traffic and Motor Vehicle Safety Act.

REV Recreation Group, Inc. (REV), on behalf of Renegade RV's manufacturing center located in Bristol, Indiana, has decided that a safety defect which relates to motor vehicle safety exists in certain Class C motorhomes manufactured by Renegade RV:

Class C

WHAT IS THE PROBLEM?

On motorhomes affected by this recall, the structural support for the side-facing sofa seatbelt attachment hardware installed in the floor framing during original motorhome production does not meet the specifications for seat belt anchorages.

In the event of sudden braking or a vehicle crash, the seatbelts may detach from the floor framing, posing a risk of personal injury.

WHY IS THIS AN INTERIM LETTER?

A final remedy for your vehicle is still undergoing development and testing. When the final remedy is available, owners will be instructed to bring their vehicles to a Renegade RV dealer to have the recall performed.

WHEN WILL THE ACTUAL RECALL LETTER ARRIVE?

A final notification date has not been determined as of the date of this letter. When the remedy is available, REV will notify you by letter to contact Renegade RV for assistance with scheduling a service appointment with a Renegade RV approved servicing dealer. Repairs will be performed free of charge.
