Triple E Recreational Vehicles Recall CA#8690-1

This notice is sent to you in accordance with the requirements of the National Traffic & Motor Vehicle Safety Act. Triple E Recreational Vehicles has decided that certain 2017 & 2018 Wonder W24MB motorhomes manufactured between September 2016 & September 2017 fail to conform to Federal Motor Vehicle Safety Standard

### Description of Noncompliance:

The Truma water heater door blocks the furnace air intake & exhaust when open and suspended by the straps. If the door is left open when the furnace is on, the water heater door may melt, increasing the risk of a fire.

### To Have This Modification Performed:

We request your assistance to have this Safety defect corrected. A decal to be installed on the water heater door is not available at this time. When the decal is available a second notification will be issued at that time.

**If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.**
