Topic: UPDATE: Stop Sale / Stop Delivery Non-Compliance Recall - R 1200 GSA

The Stop Sale/Stop Delivery for the R 1200 GSA (K51) announced on July 28th, 2017 remains in effect. A stopgap measure is targeted to be announced on August 11th. Until this measure is announced dealers cannot sell or deliver these bikes.

As a reminder new measures are being implemented to flag vehicles affected by recalls in the sales and warranty systems this month. However, DCS messages serve as official notification of any stop sale or recall as flagging of VIN's may be delayed when a stop sale or recall is announced.

NHTSA Statement

Please be reminded that it is a violation of federal law (The Safety Act) for you to sell, lease or deliver any new motor vehicle covered by this notification until the recall repair has been performed. This means that centers may not legally deliver new motor vehicles to consumers until they are fixed or use/sell replacement equipment/parts subject to this recall. Note also that substantial civil penalties apply to violations of the Safety Act.

Also, you should not sell, lease or deliver any used vehicles subject to a safety recall until the repair is completed. Please follow any special instructions that we provide to you for the return or disposition of recall parts.

The STOP SALE is still in effect for luggage cases for the below models:

R 1200 GS

R 1200 GSA

R 1200 R

R 1200 RS

S 1000 XR

F800 GT



F 800 R

The side cases cannot be retailed as of July 28th, 2017 as they would cause a non-compliance when installed on the motorcycle. Side cases in dealer inventory must be held and cannot be sold. This includes retrofitting aluminum cases to R 1200 GS (K50) as both the aluminum bags and luggage holder are affected. The related part numbers continue to be blocked from dealer ordering until further notice. A part number list for reference has been attached.

A solution is still under development with estimated resolution for most models to be available in 2-3 weeks. We will provide the next update on August 11th.
