Dear Mercedes-Benz Sprinter Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler AG, the manufacturer of Mercedes-Benz Sprinter vehicles, has decided that a defect, which relates to motor vehicle safety, exists in certain Model Year 2016 Mercedes-Benz Sprinter vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the CONCERN?

Certain Mercedes-Benz Sprinter vehicles with an optional reinforced front axle may have been equipped with incorrect tire pressure labels on the B-pillar, showing a tire pressure which might be too low. Therefore, these vehicles may be operating with a tire pressure below specification which could possibly damage the tire over time. This could lead to an increased risk of a crash and injury to occupants.

What will your DEALER DO?

An authorized Mercedes-Benz Sprinter dealer will check and replace the tire pressure label as needed, as well as, verify the correct tire inflation pressure of the affected vehicle. **This service will be provided free of charge.** While the minimum repair time is approximately **1/2 hour**, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz Sprinter dealer will also check for other repair measures which might be applicable to your vehicle which may increase the required working time. You will not be charged for other service or repairs unless so requested.

Reimbursement to Customers for Repairs Performed Prior to Recall

If you have already paid to have this recall condition corrected you may be eligible to receive reimbursement. Requests for reimbursement may include parts, labor, fees and taxes. Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Mercedes-Benz dealer. The following documentation must be presented to your dealer for reimbursement.

Original or clear copy of all receipts, invoices and/or repair orders that show:

- The name and address of the person who paid for the repair.
- The Vehicle Identification Number (VIN) of the vehicle that was repaired.
- What problem occurred, what repair was done, when it was done and who repaired it.
- The total cost of the repair expense that is being claimed.
- Proof of payment of repair (copy of front and back of cancelled check, or copy of credit card receipt).
- Reimbursement will be made by check from your dealer. If your claim is denied you will receive a letter from MBUSA within 60 days of receipt with the reason(s) for the denial.
