Subject: Fuel Line may Burst if Filter Screen Clogs

Problem Description:

Cummins Inc. (Cummins) is recalling certain ISX15 diesel engines, part number D103012BX03, and X15 diesel engines, part number D103016BX03. These engines have nylon fuel lines and were built with a banjo bolt containing an integrated single screen filter on the fuel pump. The fuel pump cooling circuit screens may become restricted by debris from filtration material causing the fuel line to burst when the vehicle is operated under certain driving conditions, such as on a long down-hill grade.

Consequence:

If the fuel line bursts, a significant amount of fuel may leak onto the road resulting in a roadway hazard for other motorists. The engine may also stall, increasing the risk of a crash.

Remedy:

The remedy for this recall is still under development. The manufacturer has not yet provided a notification schedule. Owners may contact Cummins customer service at 1-800-286-6467.

We have received Cummin's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
