This letter serves to acknowledge Mazda North American Operations's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. AIR BAGS:PASSENGER SIDE FRONTAL

Potential Number of Units Affected: 160

Problem Description:

Mazda North America Operations (Mazda) is recalling certain 2006 B-Series vehicles. Upon deployment of the passenger side frontal air bag, excessive internal pressure may cause the inflator to explode.

Consequence:

In the event of a crash necessitating deployment of the passenger's frontal air bag, the inflator could explode with sharp metal fragments striking the vehicle occupants, potentially resulting in serious injury or death.

Remedy:

Mazda will notify owners instructing them not to drive their vehicles. Dealers will replace the passenger's frontal air bag inflator with an alternate inflator, free of charge. The recall is expected to begin January 19, 2018. Owners may contact Mazda customer service at 1-800-222-5500. Mazda's number for this recall is 2318A.

We have received Mazda's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
