## **Problem Description:**

Forest River, Inc. (Forest River) is recalling certain 2018 Cardinal recreational trailers, models CAF3045RLLE, CAF304SR, CAF322DS and CAF392RD. These vehicles were manufactured without an emergency exit window in the rear wall of the vehicle.

## **Consequence:**

Without a secondary means of escape from the vehicle, a person may be trapped inside the vehicle during an emergency, which could increase the risk of injury.

## **Remedy:**

Forest River will notify owners, and dealers will install an emergency exit window, free of charge. The recall is expected to begin March 28, 2018. Owners may contact Forest River customer service at 1-574-206-7600. Forest River's number for this recall is 15-0626.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
