### **Problem Description:**

American Custom Golf Cars (ACG) is recalling certain 2016-2017 Moke vehicles. These vehicles may have been built with windshields that do not have laminated glazing. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 205, "Glazing Materials," and number 500, "Low Speed Vehicles."

## **Consequence:**

In the event of a crash, if the non-laminated windshield shatters, it can increase the risk of injury.

## Remedy:

ACG will notify owners, and dealers will inspect the windshield, replacing any that are not properly labeled AS-1 windshields, free of charge. The recall is expected to begin March 15, 2018. Owners may contact ACG customer service at 1-909-597-2885. ACG's number for this recall is ACG-RC2018-01.

We have received ACG's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
