vehicle control and a crash, resulting in personal property damage or injury.

Chronology:

3-5-2018: LCI inspected unit sold by KZ RV with an alleged deployed awning at dealership in Cleveland, Ohio. There were no reported injuries or property damage. LCI subsequently opened an investigation into the possible inadvertent deployment of Solera Smart Arm awnings. Review of the available field information revealed no other reports of inadvertent deployments from other OEMs, distributors or end users. 3-12-2018: LCI met with KZ RV to review of results from field inspection in from Cleveland, Ohio, and reported no evidence or a design or manufacturing defect. LCI inspected vehicles in KZ RV's inventory and audited the awning installation procedure in all KZ RV production plants. No issues identified. 4-17-2018: A field product issue on Solera Smart Arm awnings is identified by LCI and TSB 01-002-18 is issued to the field. The TSB instructs technicians to take measures to seal the controller wiring harness connector against potential corrosion. On May 07, 2018, LCI files the TSB with NHTSA pursuant to Part 579.5. 4-17-18: KZ RV files its Part 573 Defect Information Report for Recall 18V-242.

5-22-18: LCI exchanges calls with NHTSA ODI regarding TSB 01-02-18, informing NHTSA that LCI's outreach to other OEMs using the Solera Smart Arm awning revealed no other reports of inadvertent awning deployment while the vehicle was in motion.

6-4- 18: As a continuing product improvement, LCI implemented a design change to the Solera Smart Arm awning assembly to minimize water intrusion into the awning's controller module and wiring harness. 6-26-18: LCI concluded that it will notify NHTSA, its OEM and distributor customer that, while LCI has no evidence that the Solera Smart Arm is defective and poses an unreasonable risk to motor vehicle safety, it will nevertheless file a Part 573 Defect Information Report and conduct a safety recall campaign of aftermarket Solera Smart Arm awnings manufactured from 4-18-17 to 6-3-18.
