Descriptive Information : The subject part is a frame mounted spare tire carrier.

Description of Noncompliance :

Description of the Noncompliance : TAP Worldwide, LLC has determined that the subject Poison Spyder Frame Mounted Tire Carrier does not comply with FMVSS 108 because the tire carrier does not provide a license plate lamp or center high-mounted stop light. TAP Worldwide, LLC has also determined that the subject Poison Spyder Frame Mounted Tire Carrier does not comply with FMVSS 111 because the tire carrier renders the rear view camera inoperable.

FMVSS 1 : 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS 2 : 111 - Rearview mirrors

Description of the Safety Risk : An inoperable center high mounted stop lamp may not properly alert following vehicles that the vehicle is coming to a stop, which increases the risk of crash. Additionally, when reverse gear is selected, the rear camera view would not be available. Because the rear view camera would not be available, if the driver does not check his or her surroundings before reversing, there is an increased risk of crash.

On December 7, 2018, TAP Worldwide, LLC determined that a noncompliance with FMVSS 108 and 111 existed due to interference with the backup camera, license plate lamp, and center high mounted stop lamp.

Description of Remedy :

Description of Remedy Program : TAP Worldwide, LLC will provide replacement Frame Mounted Tire Carriers that will include the original equipment backup camera and will not interfere with the license plate lamp or center high mounted stop lamp.

How Remedy Component Differs from Recalled Component : The replacement Frame Mounted Tire Carrier will not render inoperable the backup camera, license plate lamp, or center high mounted stop lamp.
