("LCI") has conducted a thorough investigation and decided that a defect which relates to motor vehicle safety exists in vehicles equipped with a certain LCI Power Tongue Jack (the "SMART Jack") for installation and use on towable recreational vehicles. There is the potential of a structural fracture of the top portion of the SMART Jack which may allow water intrusion and unintended movement of the SMART Jack. These SMART Jack's were installed on certain 2018 Little Guy Max travel trailers between 5/31/2017 and 7/31/2017.
