Description of the Defect : The GVWR of the EC model is higher than the range of the safety chains installed on LCI frame by LCI.

2017 GVWR is 12,250lb and 2018 GVWR is 12,500lb... with both model years having safety chains rated at 11,700lbs

Description of the Safety Risk : Underrated safety chains may allow unit to detach from towing vehicle , increasing risk of a crash with personal injury and/or property damage.

Description of the Cause : Discrepancy in vendor/ Jayco Engineering frame prints and data on record.

**Chronology :**

12-27-2017 discrepancy was reported between Engineering and LCI data / prints - frames specific to the Eagle Travel Trailers. Investigation started immediately and found that the safety chains installed by LCI to their frame for the EC model, did not match information / prints on file with Jayco Engineering. Issue / findings were presented to Jayco Corp. Safety Steering Com.1-25-2018 , who decided a Recall was required.

**Description of Remedy :**

Description of Remedy Program : Jayco dealer will remove underrated chains and install new safety chains (16,200lb) at no charge.

How Remedy Component Differs from Recalled Component : NR

Identify How/When Recall Condition was Corrected in Production : All affected EC Eagle TT of frame ratings and creation of new check point internally to audit GVWR and rating of safety chains.

**Recall Schedule :**

Description of Recall Schedule : Jayco Dealers will replace the original 11,700 lbs chains with 16,200rated chains at not charge to current owner on record. - We are prepared to release recall upon receipt of assigned recall number from NHTSA.
