## **Chronology:**

During a routine internal Corporate Quality Control Inspection of the Cardinal plant's manufacturing processes, on January 24, 2018, the in-house auditor discovered a possible issue involving a missing secondary egress window in specific models. The same day, Forest River's Cardinal Division contacted Forest River's Office of Corporate Compliance ("OCC") and an investigation into the issue was initiated. On January 27, 2018, OCC received further information from the manufacturing plant which verified the secondary egress was not installed per RVIA ANSI 119.2 code.

Forest River reviewed internal data and found no warranty claims or customer complaints potentially related to this issue.

On January 26, 2018, Forest River's Corporate Committee decided to conduct a recall.

On July 26, 2018 Forest Rivers Cardinal Division notified OCC of nine-teen additional vehicles that had not been accounted for during the model change in September 2017. Forest River again reviewed internal data and have not found and warranty claims or customer complaints related to this issue.
