Description of the Noncompliance : Recalled vehicles are equipped with at least one three-place seat having Type 1 seat belts and are built with the floor structure that failed the Federal Motor Vehicle Safety Standards (FMVSS) number 207, "Seating systems" and number 210, "Seat belt assembly anchorages" test

During certification procedures, the FMVSS 207/210 test conducted in November 2018 failed. A second test confirmed the results and it was concluded that 3-place seats equipped with at least one Type 1 seat belt may not be compliant with the requirements of the Federal Motor Vehicle Safety Standard (FMVSS) number 207, "Seating systems" and number 210, "Seat belt assembly anchorages."
