**Description of the Defect :** Certain vehicles were equipped with Kidde Corporation fire extinguishers that are subject to USCPSC recall number 18-022. The fire extinguishers can become clogged or require excessive force to discharge and can fail to active during a fire emergency. In addition, the nozzle can detach with enough force to pose an impact hazard.

On or about February 1st internal inventory audit discovered that Supreme had in its possession extinguishers that were under recall. Supreme was not able to determine which vehicles these were installed in or verify if Supreme had received these extinguishers previously. On February 19th it was determined that in an abundance of caution Supreme will recall all units produced within the last ten years with a fire extinguisher installed.

**Description of Remedy :**

Description of Remedy Program : Supreme will notify owners, instructing them to contact Kidde to get a replacement fire extinguisher, free of charge. The recall is expected to begin in April 2018.
