13 March 2018 - Autocar receives notification from the field of a pre-delivery inspection that found the pinch bolt could be easily turned. 14 March 2018 - Autocar implemented containment action and started investigation. 16 March 2018 - Autocar implemented corrective and preventive actions in production. 5 April 2018 - Autocar's Product Integrity Committee met to discuss the issue and decided to release a Safety Recall.

Description of Remedy:

Description of Remedy Program: Autocar will voluntarily initiate an owner notification and recall of all

affected vehicles. Autocar will distribute to owners of affected vehicles an Owner Notification Letter which will describe the defect and provide instructions for scheduling repair of the vehicle at no cost to the owner.
