Description of the Noncompliance : The placard incorrectly states the tires' PSI as 54 PSI. The tires' correct PSI is 65.

FMVSS 1 : 110 - Tire selection and rims

FMVSS 2 : 567 - Certification

Description of the Safety Risk : A user may under inflate the tire, increasing the risk of a tire blow out and increasing the risk of a crash.

Description of the Cause : During the data entry of the new vehicle, the incorrect tire PSI was assigned to the vehicle.

Chronology :

On March 30, 2018, Forest River's Office of Corporate Compliance (OCC) received a report from the Salem Oregon manufacturing plant of a potential issue involving the information printed on the Federal Placards after the plant had received a warranty claim which indicated that the stated PSI may have been incorrect Forest River initiated an investigation including a review of the printed federal placards and the tire designation which revealed that the PSI was understated.

On April 6, 2018, Forest River's Corporate Committee decided to conduct a recall to address this issue.

Description of Remedy :

Description of Remedy Program : Forest River will provide replacement placards that contain accurate tire PSI, free of charge, to both Owners and Dealers.

Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
