Description of the Defect : The affected vehicles may be equipped with a Manufacturer Certification Label that lists an incorrect weight limit. As such, these vehicles fail to comply with the requirements of 49 CFR Part 567 "Certification". the correct specifications are for Centenario Coupè GVWR 4519 lbs ; GAWR (F) 2050 lbs; GAWR (R) 2491 lbs
Centenario Roadster GVWR 4630 lbs ; GAWR (F) 2094 lbs; GAWR (R) 2535 lbs

Description of the Safety Risk : If the listed weight limit is incorrect on the label the vehicle may be overloaded exceeding the Gross Vehicle Weight Ratio (GVWR).

Description of the Cause : An error on the data present on the production system generated the use of a non-correct value instead of the correct weight limit

Chronology :

During an internal check concluded in April 2018 after a Customer Complaint outside of US territory Automobili Lamborghini found that in the production system was present a wrong weight information on the Manufacturer Certification label present on Centenario models.
That also affects the car sold in US.
April 11 2018 the issue was presented to Lamborghini's Product Safety Committee and a determination of noncompliance was made.

Description of Remedy :

Description of Remedy Program : Automobili Lamborghini S.p.A. will notify all owners of affected vehicles and will instruct them to arrange for an appointment with an authorized Lamborghini dealer. Dealers will install a corrected Manufacturer Certification Label free of charge.

How Remedy Component Differs from Recalled Component : The corrected Manufacturer Certification Label lists the real weight limit of the vehicle.

Identify How/When Recall Condition was Corrected in Production : All Centenario limited edition vehicles were already produced and the ones still in factory grounds had the label verified and replaced started from February 2018.
