Description of the Defect: The subject vehicles are equipped with a hydraulic clutch actuator that may

have been produced with burrs on the inner actuator housing that could damage an inner oil seal over time. A damaged oil seal could allow oil to leak into the phase cap area. If oil accumulates in the phase cap area, an electrical

short could occur and increase the risk of a fire.

Description of the Cause: The hydraulic clutch actuator may have been produced with burrs on the inner
