- On February 15, 2018, the FCA US LLC ("FCA US") Vehicle Safety and Regulatory Compliance ("VSRC") organization opened an investigation due to recent inputs of 2018 MY Jeep Cherokee fires and the discovery of a related quality issue, which was opened on December 11, 2017.
- On February 19, 2018, a vehicle review was conducted to understand the location and routing of the fuel supply tube as well as identify potential ignition sources in the vicinity of the fuel supply tube.
- On February 27, 2018, Supplier Quality Engineering ("SQE") contacted the supplier, Copper Standard, to schedule a visit.
- On March 12, 2018, SQE reviewed scrap data and maintenance records at the supplier to determine the start of the suspect period.
- On April 5, 2018, SQE and VSRC investigators reviewed the investigation at the supplier's facility and observed the corrected insertion process.
- On April 6, 2018 SQE established root cause and suspect product.
- As of April 20, 2018, FCA US identified approximately 2 CAIRs, 0 VOQs and 1 field report related to this issue.
- As of April 20, 2018, total warranty is 5 at .093/1000.
- As of April 20, 2018, FCA US is unaware of any accidents or injuries related to this issue.
- On April 25, 2018, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.
