#### **Description of Noncompliance :**

	Certain 2018 model year Ford EcoSport vehicles were shipped to the U.S. Federal Territories with the European brake reservoir pictogram cap label and European English language owner's manual kits. The units shipped to the 50 U. S. states are not affected.
	Although the European brake fluid reservoir pictogram cap meets all the applicable performance requirements, the pictogram cap label does not contain the text prescribed by FMVSS 135, Section 5.4.3. Additionally, the European English language owner's manual kit does not contain certain information required by Part 575 and multiple Federal Motor Vehicle Safety Standards.
	Ford is not aware of any related reports of accident or injury.
FMVSS 1 :	135 - Light vehicle brake systems
FMVSS 2 :	
Description of the Safety Risk :	Without the required warning, owners familiar with the FMVSS 135 cap labeling may be confused by the European pictogram cap and may either mistakenly refill the brake fluid with the incorrect replacement brake fluid, not know to clean the cap, or not fill from a sealed container. Any of these errors could affect brake performance, increasing the risk of a crash.
	Part 575 and multiple Federal Motor Vehicle Safety Standards require specific language to be included in the owner's manual to reduce the risk of crash or injury.
Description of the Cause :	The incorrect brake fluid reservoir cap and owner's manual kits were released for vehicles produced for the U.S. Federal Territories.

Assembly Plant found the brake fluid reservoir cap installed on a Puerto Rico export vehicle was the European brake reservoir pictogram cap. An investigation on part releases was initiated with Chassis Engineering and the Chennai Plant Vehicle Team for the reservoir cap. An investigation to assess proper release for other potentially affected components was also initiated.

On April 26, 2018, a subsequent vehicle audit of regulatory content conducted at the Chennai Assembly Plant identified that the owner's manual kit installed on the vehicle was the European English language owner's manual kit.

On May 3, 2018, three vehicles were inspected at a Ford dealership in Puerto Rico; the European brake reservoir pictogram cap and European English language owner's manual kit were installed in these vehicles.

On May 7, 2018, Ford's Field Review Committee reviewed this concern and approved a field action.
