Description of the Defect : Certain vehicles in a specific time period produced with insufficient coated brake caliper pistons. Not all vehicles built in this time period are affected.
Audi: Due to a supplier production issue, the brake caliper piston coating was not applied according to manufacturing specifications. This can allow gas bubbles to form in the brake system, reducing vehicle brake performance and increasing the risk of a crash.
Volkswagen: Gas bubbles may form in the brake system due to insufficient chrome coating of the brake caliper pistons. Chronology :

VOLKSWAGEN:

On or around May 17, 2018: Volkswagen Chattanooga began to find vehicles on the outbound yard with low or soft brake pedal feel. All outbound shipments were stopped. Also, cases were found in ports outside of the United States. Analysis was started.

May 18, 2018 First Stop Orders for In-transit vehicles were sent out.

May 21, 2018: Supplier informed Volkswagen about a possible issue with brake caliper pistons produced in a certain time period. Analysis started.

May 25, 2018: Topic was presented in the Volkswagen AG Product Safety Committee and a determination of defect was made. Stop-sale was issued for all potentially affected vehicles in dealer inventory.

June 29, 2018: Volkswagen AG Product Safety Committee determines recall repair will be to bleed the front and rear brake calipers.

AUDI:

May 2018: Routine internal testing identifies a 2018 model year Audi Q5 vehicle with a reduction in rear brake system performance.

May 16, 2018: Audi AG issues a stop order to halt 2018 model year Audi Q5 vehicles in transit from the factory while the issue is being researched.

May 30, 2018: The topic is presented in the Audi AG Product Safety Committee and the recall determination is made.

June 01, 2018: Stop-sale was issued for all potentially affected vehicles in dealer inventory. Audi of America will begin making outbound calls to owners of affected vehicles to advise them of the recall and offer a loaner vehicle.

Description of Remedy :

Description of Remedy Program : Affected Audi models: Bleed the rear brakes.
Affected Volkswagen models: Bleed the front and rear brake calipers.
Because all vehicles are New Vehicle Limited Warranty, neither Volkswagen nor Audi will offer a reimbursement program under this recall.

How Remedy Component Differs The remedy for Audi is to bleed the rear brakes; no parts needed.

from Recalled Component : The remedy for Volkswagen is to bleed the front and rear brake calipers. No parts needed.
