Description of Defect:

Description of the Defect: If a child restraint with a larger than recommended base is installed in the

center position of the second row bench seat, it may damage both the center

and adjacent outboard safety belt buckles.

FMVSS 1: NR FMVSS 2: NR

Description of the Safety Risk: A damaged safety belt buckle can release unexpectedly, increasing the risk of

injury in a crash.

Description of the Cause: Child restraints with a base wider than 320mm (12.6 inches) have the most

potential to cause damage. Advice regarding child restraint selection for use in the second row bench center position (due to that seating position being narrower than the outboard positions) is missing from the vehicle owner's manual.

Identification of Any Warning In some cases there may be little discernible indication to the customer that the that can Occur: function of the seat belt buckle is inhibited.

Chronology:

May 2017: A Volkswagen employee reports a damaged second row bench seat safety belt buckle; this is reviewed/analyzed as a single incident case.

September/October 2017: Volkswagen begins receiving field complaints about damaged second row bench seat safety belt buckles. An investigation into the cause is started, using various child restraints and testing to attempt to reproduce failures and understand effects.

April 18, 2018: The topic was presented to Pre-Product Safety Committee at Volkswagen AG, and additional information was requested.

May 30, 2018: The topic was presented to the Volkswagen AG Product Safety Committee where the determination of defect and recall decision was made.

Description of Remedy:

Description of Remedy Program: At no cost to customers, the second row bench seat center and adjacent

left (outboard) safety belt buckles will be inspected and, if necessary, replaced. Volkswagen will also provide an owner's manual supplement

addressing child safety and child restraints.

How Remedy Component Differs If a damaged safety belt buckle is found during inspection, it will be from Recalled Component: replaced; the remedy component has the same part number than the recalled component: Seat belt buckle with part No. 3CN.857.739 or

3CN.857.739.A, depending on which buckle is damaged.

Volkswagen will also provide an owner's manual supplement addressing

child safety and child restraints.
