Chronology :

In September 2017 Daimler AG started initial investigations based on feedback from the Australian Vehicle Preparation Center regarding a vehicle with a missing top tether anchorage point on the center position of the rear seat bench.

In late 2017 analysis showed that certain vehicles might be missing the top tether anchorage point on the center position of the rear seat bench. The error was due to incorrect documentation.

Immediate action led to rework of all affected vehicles still available in the production plants. In May 2018, after a review of plant actions, Daimler concluded that some vehicles were released by the production plant. Subsequently, Daimler determined which vehicles in the field were potentially affected. In June 2018, Daimler AG determined that a potential non-compliance of subject vehicles with the requirements of FMVSS 225 S4.4 could not be ruled out.

Description of Remedy :
