Description of the Defect: Due to an inappropriate manufacturing process during the production of

certain curtain air bags, the air bags may not unfold properly during

deployment. This may result in an increased risk of injury to a passenger in a crash where the curtain air bag deploys during a side impact or a rollover

event.

Description of the Safety Risk: This may result in an increased risk of injury to a passenger in a crash where

the curtain air bag deploys during a side impact or a rollover event.

Description of the Cause: Due to an inadequate drying process after having applied silicone to the base

fabric of the curtain air bag, the adhesion performance between the silicone

and base fabric may be insufficient and an air leak may occur during deployment, resulting in the air bag not unfolding properly.
