Description of Defect :

Description of the Defect :	General Motors has decided that certain 2016-2018 Cadillac CT6 vehicles may not comply with Federal Motor Vehicle Safety Standard (FMVSS) No. 225, "Child restraint anchorage systems." During the vehicle assembly process, small amounts of excess structural adhesive may have been accidentally applied to one or both of the vehicle's inboard child-seat anchorage bars. Hardened adhesive may cause portions of an anchorage bar to exceed FMVSS 225's diameter requirements and interfere with child-seat installation.

FMVSS 2 :	NR
Description of the Safety Risk :	If this condition is present, the owner could be unable to use the anchorage bars to install a child seat. Until the recall repair is performed, owners should install child seats in the subject vehicles using the vehicle's rear seat belts, in accordance with the vehicle owner's manual and child-seat manufacturer's installation instructions.
Description of the Cause :	Structural adhesive on the underside of a vehicle body panel was inadvertently transferred to one or both of the inboard child-seat anchorage bars as the panel was lowered into position during vehicle assembly.

Chronology:

On February 15, 2018, a GM employee inspecting a 2018 model year Cadillac CT6 discovered a small amount of body adhesive on one of the vehicle's inboard child seat anchorage bars. On February 26, 2018, after inspecting other 2018 model year Cadillac CT6 vehicles in GM's possession and observing the same condition, a GM employee filed a Speak Up For Safety report.

GM's preliminary investigation found no field reports of the condition in 2018 model year Cadillac CT6 vehicles. On April 10, 2018, GM opened a formal product investigation to expand the scope of the field-data review to 2016 and 2017 model-year vehicles and determine whether the condition caused a potential noncompliance to FMVSS 225.

GM found no field reports of the condition in all Cadillac CT6 model years (2016-2018). From mid-May through early June 2018, GM inspected additional GM-owned CT6 vehicles as well as employee-owned vehicles; tested whether the condition could impact child-seat installation; and measured the condition's effect on anchorage-bar diameter. GM's inspections confirmed that the condition could be present in any CT6 vehicle built at GM's Detroit-Hamtramck facility prior to September 21, 2017, when the plant altered a specific bodyadhesive application process. GM also confirmed that hardened adhesive could cause portions of an anchorage bar to exceed FMVSS 225's diameter requirements and potentially interfere with child-seat installation. Based this data, on June 21, 2018, GM's Safety and Field Action Decision Authority (SFADA) decided to conduct a noncompliance recall.

Description of Remedy :

Description of Remedy Program :	Dealers will inspect the inboard child seat anchorage bars for adhesive. If
	found, the dealer will remove the adhesive and apply an anti-corrosion
	primer to the bar. Pursuant to 49 C.F.R. § 573.13(d)(1), all covered
	vehicles are under warranty so reimbursement is not offered.
