Description of the Defect : According to the recall notice provided by Chevrolet; "Liquid can enter the power window switches in these vehicles and cause corrosion, leading to high electrical resistance."

Description of the Safety Risk : According to the recall notice provided by Chevrolet; "High electrical resistance can cause the switch to heat up, smoke or melt, increasing the risk of fire and injury."

Identification of Any Warning that can Occur : According to the recall notice provided by Chevrolet; "Occupants may notice that the power window is malfunctioning or inoperative. Smoke or an odor from smoke or melting may also come from the door panel."

On July 2, 2018 Forest River's Office of Corporate Compliance received Chevrolet's recall notice containing the VINs affected under Chevrolet Recall Number 18V295. The same day an investigation to identify the involved vehicles was completed.

On July 3, 2018, Forest River's Corporate Committee was advised of the recall.

On August 20, 2018 OCC received 12 additional recall notices from Chevy. Increasing the population from 43 to 55 affected vehicles.
