Description of the Defect : The propane system testing was not properly done during the manufacturing process. Vehicles not properly tested could have a propane gas leak at the back of the outside kitchen cooktop.

Description of the Safety Risk : Vehicles not properly tested could have a propane gas leak at the back of the outside kitchen cooktop. If a gas leak occurred a fire or explosion could occur which could result in personal injury.

6-20-2018 A warranty claim is received indicating a leak during a PDI check at a dealership. Warranty investigates further with dealer. Based on reporting and photos received from dealer, the information is forwarded to the Safety Committee for further review on 6-26-2018. 6-26-2018 a safety committee meeting is held and this is forwarded for investigation and PDI testing is ordered. Based on findings, Yard is put on hold and all units in inventory and at transportation lots are put on hold for retesting. Scope is unknown at this time. 7-3-2018 Safety committee meeting is held to review findings and vote to issue a recall.
