Descriptive Information :	The recall population was determined to affect only 2018 MY Atlas vehicles built during a specific time period. Additionally, vehicles that have already received repairs due to a twisted drain tube (but where the airbag control module was not replaced) are identified to be contained within this recall so that the module replacement can be made.

#### **Description of Defect :**

Description of the Defect :	In certain vehicles, an air conditioning evaporator (HVAC) drain tube may have been twisted during vehicle assembly. If this tube is twisted, it can lead to water draining inside the passenger compartment and also onto the airbag control module. If the airbag control module gets wet, it can malfunction and possibly lead to an unintended airbag deployment.

Description of the Safety Risk :	An unintended airbag deployment can cause injuries to vehicle occupants and possibly lead to a crash.
Description of the Cause :	Water may leak from an improperly installed HVAC drain tube to the airbag control unit. This may cause electrical malfunctions within the airbag control

#### **Chronology** :

August 30, 2017: Topic was presented to Volkswagen's product safety committee. Only complaints known for wet carpet or airbag warning lamp on with a de-activated airbag control unit. Topic evaluated and assessed as early failure and not safety relevant, no further claims expected. Topic addressed as service campaign. October 25, 2017: Topic was presented to NHTSA. Topic was not considered as safety relevant therefore service campaign initiated.

June, 14, 2018: VWGoA received case about curtain airbag deployment without cause. Analysis started. August 8, 2018: Topic was presented to Volkswagen's Product Safety Committee and re-evaluated due to new knowledge of inadvertent deployment risk [or potential]. Determination of defect was made and recall decided.

#### **Description of Remedy :**

Description of Remedy Program :	The HVAC drain tube will be inspected on all affected vehicles. If a twisted tube is found, the hose as well as the airbag control module will be replaced. A subset of affected vehicles (that our records show have had a twisted drain tube replaced in the past) will have the airbag control module replaced under this recall. Volkswagen will not be offering a reimbursement plan under this recall.
