incomplete rear window bonding process. Investigations determined that the glass activator on the rear window was not applied as required. In July 2018, further analysis determined, that a missing glass activator might impact the long-term adhesion of the rear window. In August 2018, the range of potentially affected vehicles was identified.

In early September 2018, DAG determined that a potential safety risk cannot be ruled out.

Description of Remedy :

Description of Remedy Program :	As a precautionary an authorized Mercedes-Benz dealer, will rework the rear window bonding. Pursuant to 49 C.F.R. § 577.11(e), MBUSA does not plan to provide notice about pre-notice reimbursement to owners since all involved vehicles remain covered under the new vehicle warranty.
How Remedy Component Differs from Recalled Component :	Rear window bonding with applied glass activator.
	A change in the production procedure ensures that this issue can no longer occur from June 15, 2018 onwards.
