# Chronology :

In August 2018, a vehicle in the assembly plant was identified with an incorrectly installed steering wheel. DTNA immediately began an investigation to determine the scope and consequences of the issue. All vehicles at the plant, factory PDI center, and transportation lot were inspected. Two other units in the assembly plant were identified with incorrectly installed steering wheels. No vehicles at the factory PDI center or transportation lot were found to have an incorrectly installed steering wheel. DTNA reviewed warranty and field reports and did not identify any claims related to this issue. Review of the production information for the 3 vehicles identified indicated that the same assembler may have installed the steering wheels on all 3 vehicles. In September 2018, DTNA attempted to identify all vehicles in which the assembler may have installed the steering wheel. Because the assemblers work in groups, DTNA was not able to identify the specific vehicles in which the assembler had installed the steering wheel. DTNA narrowed the population of suspect vehicles to vehicles that had the steering wheel installed while the assembler in question was working in the area. On October 5, 2018, out of an abundance of caution, DTNA decided to conduct a voluntary safety recall on certain Cascadia and Western Star vehicles that may have a steering wheel that was not properly installed.
