Description of the TAP Worldwide, LLC has determined that these unassembled trailer kits lack

Noncompliance : certain certification labeling required under 49 CFR 567.4, including the Gross

Vehicle Weight Rating (GVWR), Gross Axle Weight Rating (GAWR), and cargo capacity statement needed to determine compliance with 49 C.F.R § 571.110. In addition, these trailer kits were not assigned vehicle identification numbers

(VINs) which conform to the requirements of 49 CFR 565.

Description of the Safety Risk: Because these unassembled trailer kits lack certain labeling, an owner may

overload the trailer, thereby creating a risk of loss of vehicle control, a risk of wheel or tire failure, and/or a risk of vehicle crash. In addition, because these trailer kits were not assigned unique vehicle identification numbers (VINs), owners may not be able to be properly notified of future safety-related defects or noncompliance issues related to motor vehicle safety. In addition,

owners may not be able to properly register the trailer kits per state

guidelines.

Description of the Cause: This noncompliance was caused by the trailer kits lacking sufficient labeling.

Chronology:

On September 17, 2018, TAP Worldwide, LLC was contacted by the Office of Vehicle Safety Compliance (OVSC) regarding the Smittybilt SCOUT trailer kit. After a telephone conversation on September 18, 2018, it was determined that the Smittybilt SCOUT trailer kit did not comply with the certification label requirements set forth in 49 CFR Part 567 and the vehicle identification number requirements of 49 CFR Part 565. As requested by OVSC, on September 26, 2018, TAP Worldwide, LLC submitted a remedy proposal to OVSC. On October 3, 2018, OVSC concurred with the proposed remedy, which included conducting a recall of all Smittybilt SCOUT trailer kits sold with wheels and tires, so that such trailer kits could have certification labels affixed and vehicle identification numbers assigned as needed.

Description of Remedy:

Description of Remedy Program: TAP Worldwide, LLC will generate certification labels that meet the

requirements of 49 CFR 567.4 and will affix those labels to the recall population. The certification label will provide the correct GVWR and GAWR for the wheel and tire combination sold with the Smittybilt SCOUT trailer kit. For any trailer kits in the recall population that have not been registered or do not have a State Department of Motor Vehicles assigned VIN, TAP Worldwide, LLC will assist the owner with registration and the

VIN requirement.

How Remedy Component Differs NR from Recalled Component:

Identify How/When Recall Condition Future production of Smittybilt SCOUT trailer kits sold with tires and was Corrected in Production: wheels will feature certification labels which meet the requirements of 49 CFR 567.4 and which are assigned vehicle identification numbers that meet the requirements of 49 CFR 565.
