Seats not installed in the rear row of a School Bus as manufactured by CE White / HSM may not comply with impact requirements of CFR 49.571.222. Specifically, the lower knee impact area of the seat back may not meet the minimum requirements for energy absorption. The thinkness of the foam in the knee impact area of the lower seatback may e insufficient. There is an increased risk of injury to unbelted seat occupant('s) in a vehicle hard braking situation, or vehicle crash event. In a hard braking or crash event, the occupant('s) knees contact the lower seatback, resulting in injury.
