Description of the Defect: As a result of ongoing testing, Ducati has determined that at certain vehicle

speeds and engine RPMs, based on gear position, the image in the motorcycles

rear-view mirrors can become distorted.

Description of the Safety Risk: If this visibility reduction occurs, it can result in an increased risk of a crash

due to the decreased visibility behind the vehicle.

Description of the Cause: The existing rear-view mirrors could vibrate at certain frequencies and in some

specific riding conditions.

If this occurs the reflected images may not be detailed, affecting the rider's visibility rearward. Under these conditions, due to vehicle speed and engine revs, the reflected image is not clearly visible on the rear-view mirrors.
