6/21/18 – Similar issues were reported, with 5 VIN numbers, and Company began collecting data.

7/2/18 – Information and preliminary data was reported to the Product Safety Team for evaluation.

7/12/18 – PST submitted its preliminary findings to the Product Safety Council (PSC), which requested additional information to identify the scope and cause of the missing deflectors. PST continued to collect data on potential causes and provide updates to PSC.

11/5/18 – PST reviewed additional data and submitted to PSC.

11/8/18 - PSC decided to recall.
