## **Chronology**:

February 2018

Honda received a global market report that an incorrect owner's guide was found in a vehicle during a routine port quality inspection, and an investigation was launched.

March 29, 2018

Honda identified deficiencies at one manufacturing facility related to data processing and record keeping for owner's guide installation. Countermeasures were enacted to ensure accurate identification and tracking.

#### April to October 2018

Honda confirmed that in 2016, when the involved manufacturing facility had expanded responsibilities for additional export markets, the systems for managing the identification, processing, and tracking of owner's guides were inadequate to handle the increased volume. Honda began to investigate the scope and range of potentially affected vehicles.

#### November 9, 2018

Honda completed the investigation and determined that a potential for FMVSS noncompliance existed and decided to conduct a safety recall.

As of November 9, 2018 Honda has received 16 warranty claims, and no field reports nor reports of crashes or injuries related to this issue.

## **Description of Remedy :**

Description of Remedy Program :	Registered owners of all affected vehicles will be contacted by mail and asked to take their vehicle to a Honda automobile dealer. The dealer will install or replace the owner's information kit for free. Because owner's information kits are not available from third party
	sources and the limited new vehicle warranty for all affected vehicles would have provided a free repair for the problem addressed by this recall, without any payment by the owner, reimbursement for pre- notification repairs will not be offered.
